Energy renovation for our homes

Operational Programme “Regional Development” supports the implementation of energy efficiency measures in multifamily residential buildings in 36 cities:

The total amount of the grant is BGN 50 million. Specific beneficiary is the “Housing Policy” Directorate at the Ministry of Regional Development and Public Works. The project duration is three years (2012-2015).

Financial assistance for implementing energy efficiency measures will be granted to associations of owners, registered with the corresponding municipal administration in accordance with the procedure of the Condominium Management Act and in the BULSTAT Register.

GRANT AMOUNT

For each approved building owners will receive a grant in the amount of up to 50% of the budget for the renovation of the corresponding building / block section (costs of construction works; preparation of technical / executive designs; conformity assessment; copyright and construction supervision; costs related to the commissioning of the project; costs associated with obtaining the necessary authorisation documents).

Owners of individual units, in which business operations are conducted, shall pay 100% of the costs based on the share of the common areas, owned by them.

The Operational Programme will cover fully the costs of the survey for establishing the technical characteristics of the building, including the preparation of a technical passport and the energy efficiency survey.

In connection with the project implementation, the Housing Renovation Fund will support the renovation process by extending loans / providing bank guarantees.

PERSONAL CONTRIBUTION

The implementation of energy efficiency measures in multifamily residential buildings will be supported through financial engineering for extending loans / providing bank guarantees in the amount **of BGN 13,5 million** via the **Housing Renovation Fund (HRF), managed by Corporate Commercial Bank AD**. Its objective is to support associations of owners or individual owners of individual units (OIUs) in multifamily residential buildings in securing their share of 50% of the budget for the renovation of the corresponding building or block section (if the corresponding building is approved and provided that they do not have own funds).

WHAT ARE THE ADVANTAGES OF THE LOAN EXTENDED BY THE HRF?

Loans extended by the HRF offer favourable conditions for residential owners who want renovate their multifamily residential buildings. The main advantages are:

- ✓ Low interest for the entire period of the loan, calculated as the base interest rate of BNB + 6.5%, with an option to reduce the interest rate, calculated as the base interest rate of BNB + 4.5%;
- ✓ No additional application and management fees;
- ✓ Grace period of 6 months;
- ✓ Long repayment period – by the end of 2021.

WHAT ARE THE REQUIREMENTS FOR OBTAINING A LOAN FROM THE HRF?

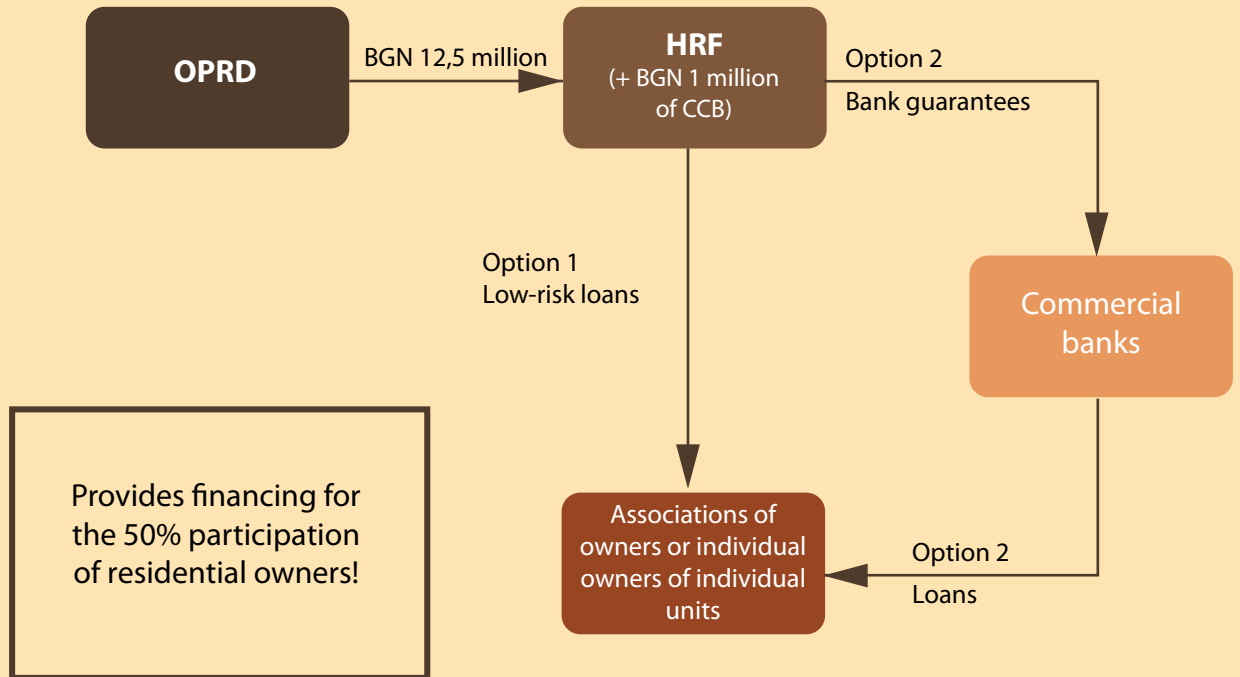
To apply for loans, residential owners need to provide the usual documents required by most commercial banks in Bulgaria. An important condition is that the household shall have available disposable income, higher than the loan instalment. The more important documents OIUs shall submit are:

- ✓ Pay-slip for the last salary;
- ✓ Employment contract (pension);
- ✓ Annual tax return;
- ✓ Documents certifying entrepreneurship income (income and expenditure statement, balance sheet, etc.);
- ✓ Rental income;
- ✓ Other documents required by the bank (marriage certificate, receipts for paid utility bills, etc.).

With regard to associations of owners, the HRF also requires the following mandatory documents:

- ✓ Association agreement;
- ✓ Information from the register of the municipal administration;
- ✓ Decision of the general meeting to request a loan.

ACTIVITIES ELIGIBLE FOR FINANCING

- ✓ replacement of joinery (windowpanes, doors, etc.);
- ✓ thermal insulation of external surrounding elements (external walls, roof, etc.);
- ✓ major repair, modernisation or replacement of local sources of heat / boiler farms or adjacent facilities, property of the owners of individual units, and fuel switching, where there are proven energy saving and environmental effects;
- ✓ construction of installations for utilisation of renewable energy sources – solar systems to provide power for own (domestic) needs, which do not generate revenue in the process of operation of the facilities;
- ✓ repair or replacement of internal heating / cooling / ventilation installations, including radiator thermostatic valves and control valves in the common areas of the building / block section;
- ✓ repair of electrical wiring in the common areas and introduction of energy efficient lighting in the building / block section;
- ✓ installing automated building management systems, including balancing, regulating and others of the consumption of heat and electricity to local sources, property of the owners of individual units, in the common areas of the building / block section;
- ✓ gasification of buildings (internal building distribution system and boiler / boilers), subject to the existence of a developed gas distribution network to the building;
- ✓ accompanying construction works associated with the implementation of energy efficiency measures and the corresponding refurbishment of the common parts of the building / block section as a result of the implemented measures with energy-saving effect.

ELIGIBILITY CRITERIA FOR BUILDINGS

Territorial scope 36 city centres.

Independent status the building / block section shall simultaneously fall within the scope of the following definitions:

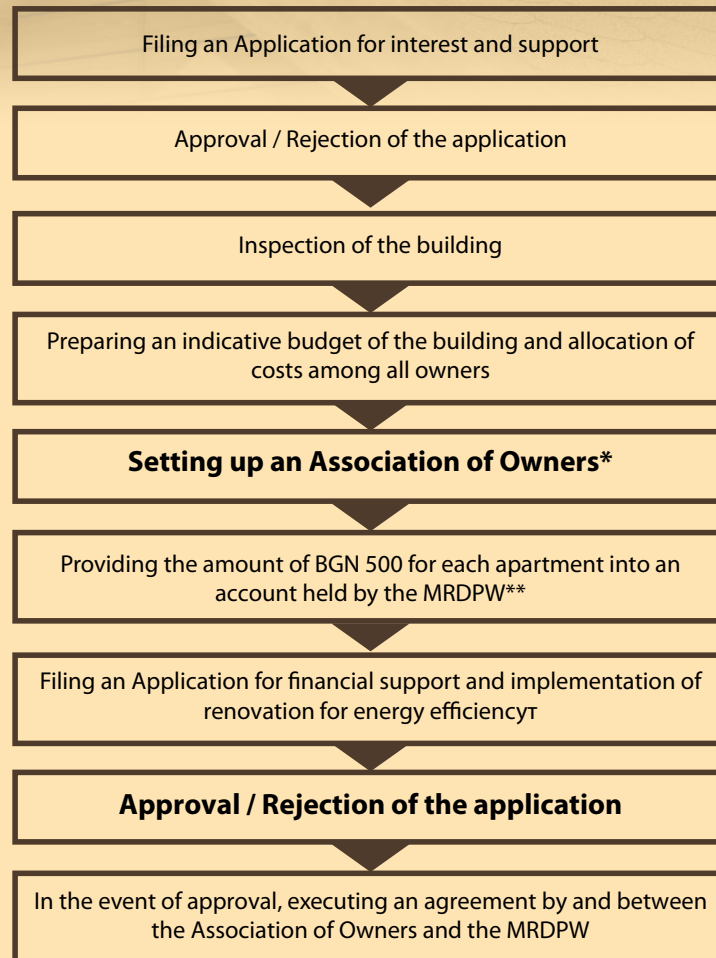
- ✓ multifamily residential building – building designated for permanent occupation, in which at least 60 percent of the gross built-up area is used as residential properties and which has 6 or more detached individual units with residential use on 3 or more floors.
- ✓ building / block section – construction unit with independent functional use, having separate structures and elements, separating it from the surrounding air, and its own individual generation of heat / cold, or has no generator of heat / cold. Building / block section is also an entrance / entrances, which cover the requirements of the previous sentence.

Age – the design of the building shall have started before 26 April 1999.

Condition of the load-bearing structure – the building shall be structurally stable (this is established as a result of the carrying out of a technical survey).



MAIN STEPS FOR APPLYING



* The association of owners shall be established and registered in the process of preparation of the application for financial support and before the filing of the application for financial support.

** This amount shall be used as part of the co-financing owed by the association of owners, and, in the event of failure to discharge the obligations under the Agreement, it will be withheld to cover the costs incurred in connection with the building / block section.

CONSENTS REQUIRED FOR THE FILING OF AN APPLICATION

Consents required for the filing of an application for interest and support

Agreement reached between the owners of individual units, representing at least 67% of the shares of the common areas. The agreement shall have the form of minutes of the General Meeting:

- ✓ resolution that the building applies for renovation under the project and authorising an individual to file an Application for interest and support to the Project Manager;
- ✓ resolution for filing an Application for interest and support to the Project Manager;
- ✓ resolution for allocation of the shares of the common areas (where necessary);
- ✓ consent of all owners of individual units to grant access to each individual unit within the condominium based on a pre-agreed time-schedule.

The consents required for filing of an Application for financial support and implementation of renovation for energy efficiency

The resolution for renovation shall be voted by the general meeting of the association of owners by owners, representing at least 67% of the shares of the common areas:

- ✓ resolution that the association of owners applies for financial support and implementation of renovation for energy efficiency under the project;
- ✓ resolution for executing an agreement by and between the association of owners and the "Housing Policy" Directorate (MRDPW);
- ✓ resolution to provide the required funds in the amount of BGN 500 for each individual unit and setting a deadline for collecting them;



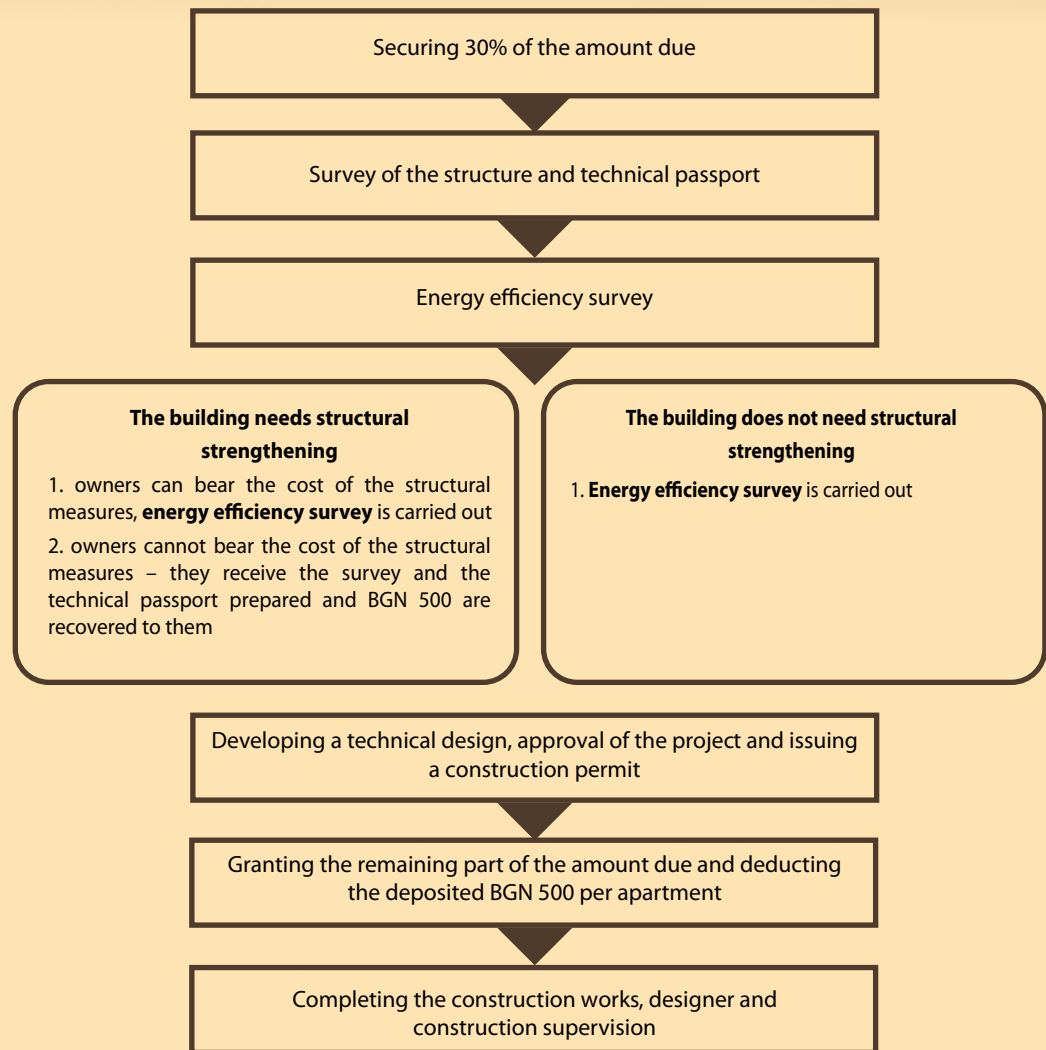
- ✓ resolution to apply for a loan / guarantee before the HRF and provide a security for the loan (where such security is required);
- ✓ solving problems with insolvent neighbours and unoccupied apartments (where necessary);
- ✓ resolution to open an account with a commercial bank (in accordance with the requirements of the “Housing Policy” Directorate) after the association of owners is approved for financial support;
- ✓ authorising a technician to the association of owners for the purpose of exercising control over the implementation of the renovation for energy efficiency.

All buildings satisfying the eligibility criteria will be assessed positively and will receive an approval for financial support and implementation of renovation for energy efficiency in the order of applying and until the available public financial resources are exhausted.

The order of applying shall be determined as from the time when all requirements are satisfied and an agreement is executed by and between the association of owners and the “Housing Policy” Directorate (MRDPW).

The documents to be provided by the owners are in standard forms. They are developed by the “Housing Policy” Directorate (MRDPW) and will be published in the MRDPW site (www.mrrb.government.bg, section Renovation of homes), in each municipality site and provided in hard copies in the “Housing Policy” Directorate.

RENOVATION STEPS



PROJECT IMPLEMENTATION

In its responsibilities of a specific beneficiary, the "Housing Policy" Directorate is supported by an *Integrated Project Implementation Unit*.

Seven Project Managers (one for each of the 6 NUTS 2 regions and one for the city of Sofia), selected in accordance with the procedure of the Law on Public Procurement, identify the residential buildings eligible for renovation, support the associations of owners in the preparation of the overall documentation for applying, prepare the energy efficiency surveys and perform conformity assessments of the investment projects in line with the material requirement of Article 169, paragraph 1, sub-paragraph 6 of the Law on Spatial Development. The cost of the services provided by Project Managers is fully covered by the project.

The Ministry of Regional Development and Public Works organise the overall renovation process. The Ministry will organise, in accordance with the procedure of the Law on Public Procurement, public procurement procedures for selecting contractors for the surveys for establishing the technical characteristics of the buildings; developing technical / executive designs; construction works; construction supervision and conformity assessment. For each approved building / block section, separate public procurement contracts will be awarded for development of technical / executive designs and construction works, and a representative of the association of owners will have the right to participate in the selection of the contractor.

Owners will be facilitated as much as possible in the renovation of their building.



EXPECTED RESULTS

- ✓ Reduced greenhouse gas emissions (CO2 and equivalent) – **15 kt/annual average**
- ✓ Economy of energy consumption in the renovated residential buildings – **21,500 MWh/p.a.**
- ✓ Number of citizens benefiting from improved housing infrastructure – **13,500**
- ✓ Improved housing infrastructure – **426,550 sq. m. gross built-up area**
- ✓ Number of renovated multifamily residential buildings / block sections – **180 buildings / block sections**
- ✓ Number of renovated residential properties – **6,100 residential properties**
